2020-21 Budget to Promote Economic Diversification, Boost Pillar Industries and Foster Talent

The 2020-21 Budget was released on 26 February by the Financial Secretary Paul Chan, offering a wide range of measures to strengthen Hong Kong's pillar industries while identifying new growth engines among emerging sectors. Additional support will be offered to the tourism industry, which has been hit hard by the economic downturn and the novel coronavirus outbreak, the Financial Secretary earmarked more than HK\$700 million for the Hong Kong Tourism Board to expand promotion and revive the industry once the epidemic is over. Similarly, the Hong Kong Trade Development Council will receive HK\$150 million in additional funding to support promotional activities and assist Hong Kong enterprises in exploring new market opportunities. HSBC Offers over HK\$30 Billion Liquidity to Hong Kong Businesses

HSBC issued new measures to provide immediate support to commercial customers, including a principal moratorium for taxi and public light bus operators and borrowers of property-secured commercial loans, cash facility up to HK\$10 million for trade finance customers, import trade loan payment extension for 30 days, handling fee waiver and guarantee fee subsidy for loans under Government SME Financing Scheme until end of 2020. The one-off scheme is launched on 1 February 2020 and will last for six months till 31 July 2020. Local SMEs will be subsidised 50 percent of its participation fee per participation in Hong Kong Trade and Development Council's exhibitions during the period, subject to a cap of HK\$10,000.
