The HKSAR Government will strive for institutional and policy innovation to assist local and overseas enterprises in Hong Kong to capitalise on the new potential to propel the Hong Kong economy up the value-added ladder. Director-General of Investment Promotion, Mr Stephen Phillips said that the report has set out very clearly the exciting opportunities for businesses from around the world in Hong Kong.
